**CNA (10)** (Non-Exempt) – Under the supervision of a Staff Nurse, provides assigned residents with routine daily nursing care. Must possess current KY Nursing Assistant Registration. Must be able to read and write. Must be able to understand and execute both written and oral instructions, and to document same. Must be able to lift an average of 150 lbs. as well as push residents in a wheelchair weighing up to 250 lbs. on a frequent basis. **Nursing. FT, PT, PRN. All shifts available.**

**Memory Care Center of Excellence / CNA (2)** (Non-Exempt) – Under the supervision of the Memory Care Center of Excellence (MCEE) Manager, is responsible for providing personal care for dementia patients. Being self motivated, analytical, and a fast problem solver is a must. Qualifying applicants **must have exemplary attendance history** as well as demonstrate extraordinary levels of sensitivity, flexibility, work ethic, and judgment. Must possess current KY Nursing Assistant Registration. The preferred candidate will have two (2) years of CNA experience in conjunction with one (1) year of direct dementia care experience. Must be able to lift an average of 150 lbs. as well as push residents in a wheelchair weighing up to 250 lbs. on a frequent basis. **Nursing. 1 PT (11PM-7AM) Tuesday, Thursday, and Saturday. 1 PT (7AM – 3PM) every other Saturday.**

**RN - House Supervisor** (Exempt) – Under the direction of the Director of Clinical Services, assesses resident care needs and implements appropriate action; while implementing nursing policies and procedures; supervising staffing and the quality of nursing care provided to the residents. Requirements include; RN license, IV certification, strong clinical skills, management and leadership experience, Medicaid & Medicare regulations, and knowledge of long term care. Two (2) years supervisory experience, MDS knowledge, and good communication and people skills preferred. Must be able to lift an average of 150 lbs. as well as push residents in a wheelchair weighing up to 250 lbs. on a frequent basis. **Nursing. FT. 11PM – 7AM. (This is a night shift position.)**

**RN/LPN (3)** (Non-Exempt) – Under the direction of the Clinical Coordinator, is responsible for providing nursing care supervising staff, maintaining up-to-date patient charts and nursing care plans for a specific facility wing. Must be a graduate of an accredited school of nursing and have a current KY license. One year of progressive long term care and knowledge of gerontological nursing preferred. Must be able to lift an average of 150 lbs. as well as push residents in a wheelchair weighing up to 250 lbs. on a frequent basis. **Nursing. 1 LPN FT (7AM-7PM). 2 RN's FT (7PM-7AM).**

**Cook** (Non-Exempt) – Under the supervision of the Dining Service Director, prepares food according to menu, established guidelines and procedures. Must maintain high standard of sanitation and safety in all areas of food preparation, service, and storage. A high school diploma or GED and/or up to three (3) years experience in the healthcare or food industry may be substituted and is preferred. Must be able to obtain Jefferson County Sanitation certification. **Dining Services. PT (various hours) every other weekend availability required and relief as needed.**
